2. Review, submit comments and develop guidance for D&D financial assurance issues. [G1 - O5]
3. Review and submit comments for D&D computer models and revisions. [G3 - O3]
4. Review and submit comments on any D&D documentation that is made available and that is important to States. [G1 - O3, O4] [G5 - O1]
5. Keep States informed of any new D&D material issued by Federal, State or industry. [G2 - O1, O2] [G3 - O4]
6. Keep States informed of decommissioning techniques that are being used and guidance on the pro's and con's of each technique. [G2 -01, 02] [G3 - 04]
7. Encourage States to support the use of MARSSIM, MARSAME, and MARLAP when applicable. [G1 - O4]
8. Develop State D&D guidance and technical documents. [G1 - O5]
9. Provide assistance to States, when requested, to support D&D activity. [G3 - O1]
10. Determine progress of D&D in the US. [G5 - O1]
11. Survey States annually to determine D&D needs. [G1 -O1]
12. Participate in the D&D activities of the American Nuclear Society. [G5 - O2]
13. To provide liaison for the CRCPD with the American Nuclear Society (ANS). [G5 - O1, O2, O3]
14. To provide a liaison for the CRCPD with the Decommissioning Section of the Health Physics Society. [G5 - 01, 02, 03]
