**Charges:**

1. To consult, comment and make appropriate recommendations concerning TENORM issues and regulatory revisions to the SR-N Committee and CRCPD Board, as appropriate.
2. To conduct a Peer Review of the proposed revision of SR-N once that proposed revision is made available to E-45 and provide comments and recommendations to the CRCPD Board and SR-N. Depending upon the extent and nature of the comments resulting from the review by E-45, it may be necessary for E-45 to meet to resolve issues and differences.
3. To design and report on a clearly worded questionnaire to be submitted to state programs and produced for regulators, industry, and the public that covers basic requirements and clarifies differences between state TENORM regulations. Evaluate the feasibility of CRCPD maintaining a compendium of state regulations and guidelines pertaining to the regulatory management of TENORM.
4. To inform the CRCPD Board of emerging issues related to the regulation of TENORM.
5. To provide the CRCPD Board, at least annually, a report on activities, successes and possible emerging issues.
6. To liaison with the Interstate Oil and Gas Compact Commission (IOGCC).
