Charges:

- 1. To keep informed on the status of the certification/credentialing of industrial radiographers and provide the interested parties with information relative to new developments. [G1 O5]
- 2. To provide comments, when requested, and recommendations concerning industrial radiography to the SR-E Committee. [G1 O4]
- 3. Every two years review the Agreement between the State of Texas and the CRCPD for providing industrial radiographer examinations for states' certification programs to determine if any changes are needed to allow CRCPD to proceed with implementing a national program for recognizing states as Industrial Radiographer Certifying Entities (IRCE).
- 4. Review the wording of new application contractual agreements between the CRCPD and every four years review those states that are currently recognized as IRCEs and determine whether any changes are needed.
- 5. Review initial applications for acknowledging states and Independent Certifying Organizations as radiographer certifiers.
- 6. Review 'draft' procedures for Initial and Periodic Review of State Certification Programs and Independent Certifying Organizations and update as needed by April 2017 and finalize.
- 7. Every four years perform periodic review of existing certification states and independent organizations to verify compliance with current requirements.
- 8. Review significant documents relating to industrial radiography certification/credentialing and provide comments as appropriate.
- 9. Consider the development of a procedure that provides for each certifying state and/or entity to share information relative to sanctions taken against a particular individual with CRCPD and/or other certifying states/entities.
- 10. Consider how to allow/use new technology in the training and certification testing by certifying states and entities.
- 11. To provide a liaison for CRCPD with the American Society for Non-destructive Testing (ASNT).

Note: When a Letter/Number combination appears in brackets after a charge, it denotes how the charge links to CRCPD's Goals and Objectives, as listed in CRCPD's Strategic Plan.
