Charges:

1. Review current CRCPD website and provide input to the Board on improvements for better information transfer and navigability on an ongoing basis.
2. Develop a protocol for use of Facebook, Twitter, Instagram, YouTube, LinkedIn, and other forms of social media. This protocol should include guidelines on the type of social media most appropriate for the type of information to be conveyed, as well as the development and approval process for posts.
3. Make recommendations on the use of social media to reach members and the radiation protection community. Provide wording, advice and strategic outreach options. This includes recommendations for routine messages and updates, as well as just-in-time messages to communicate specific occurrences and events and new information for the website. This should not preclude normal day-to-day communication and website posts by the OED.
4. Make recommendations on the use of social media to reach the radiation protection community at large.
5. Make recommendations on connecting members with each other and with other stakeholders in radiation protection through interactive tools.
6. Ensure that G-73 communications and outreach for CRCPD emphasize CRCPD's mission and goals, specifically:
  - a. Produce radiation protection solutions that meet community needs
  - b. Assist states with improving tools
  - c. Promote an active, energized membership
  - d. Enhance the profile of the organization.
