### **G-75 General Licensing Program Guideline Development Task Force**

**November 2025**

#### **Charges:**

1. Review and evaluate recommendations and conclusions of the OAS/NRC General Licensing working group as a basis for developing general license program guidelines.(G1-O3)(G1-O4)(G1-O5)(G4-O4)(G5-O1)
2. Evaluate and identify how the National Materials Program can be more consistent with respect to the general licensing programs. (G1-O3), (G1-O4), (G1-O5)(G4-O4)(G5-O1)
3. Develop a survey for CRCPD and Agreement State programs to help identify “best practices”, unique regulations and/or desired regulations.(G2-O1), (G2-O2)
4. Use survey results and previous working group conclusions and recommendations to develop a “Best Practices Program Guidelines” for general licensing that provides structure and guidance for agreement states to follow to implement an adequate GL program.(G1-O4)(G2-O1)
5. Determine if Suggested State Regulations or NRC Petition for Rulemaking are appropriate to support the GL best practices program guidelines.(G4-O3)(G4-O4)
6. Evaluate licensing practices for general and specific devices to provide clear and consistent licensing practices for state programs to follow.(G1-O3)(G1-O4)(G4-O4)
