Charges:

1. To keep informed as to activities relative to the Mammography Quality Standards Act (MQSA); provide radiation control agencies with a CRCPD contact and clearinghouse for issues relative to mammography; to provide the Conference with comments on activities occurring under MQSA. [G1 - O1, O2] [G2 - O1, O2]
2. Annually assess the feasibility of offering a MQSA Continuing Education Program in conjunction with the annual meeting. [G1 - O1, O3, O4] [G3 - O1, O3, O4] [G5 - O2, O3]
3. Assist FDA in determining “root causes” of violations, to aid in identification of trends that lead to declining performance. [G1 - O1, O4] [G2 - O1] [G3 - O3, O4]
4. Conduct a periodic evaluation of the current training and software programs for state MQSA inspectors. If the periodic evaluation determines that a more thorough professional evaluation is needed, recommend how such a professional evaluation should be conducted. [G1 - O1, O4] [G3 - O1, O2, O3, O4] [G5 - O1, O3]
5. Create a monthly or quarterly call for the state mammography programs to discuss topics related to mammography inspections and programs across the country. The call should include representatives from the H-11 members, advisors, and resources.
