Charges:

1. Oversee the development and maintenance of a national database of radiation medical events.
2. Amend as necessary, the definition of reportable radiation medical events from radiation producing machines.
3. Review submitted reports for completeness and accuracy.
4. Establish a mechanism for preparing an annual summary and an article for the Newsbrief.
5. Establish a mechanism for referring information to CRCPD subject matter committees' information to determine the need for timely notices.
6. Provide a verbal report at the CRCPD Annual Meeting.
7. Develop a pamphlet for distribution to members on therapy radiation events that should never happen with a completion date of January 2022. This pamphlet is to be a joint project with H-48.
