Charges:

1. To keep informed of federal government and agreement state issues which may impact nuclear medicine. Review any applicable acts, regulations, and guidance regarding nuclear medicine. Provide updates as needed to state program directors and the board involving nuclear medicine.
2. To develop and conduct a survey of nuclear medicine practices and develop a white paper on the results of the survey.
3. To provide information and guidance as needed to state programs regarding nuclear medicine issues.
4. To coordinate activities and reports for task groups associated with nuclear medicine and with the Liaison to Society of Nuclear Medicine and Molecular Imaging and the Nuclear Medicine Technology Certification Board.
5. Develop a guidance document on Check-Cap Colonoscopy Device. Specifically addressing the current FDA and NRC status and developing questions to assist the state regulatory programs groups when they receive inquiries or licensing requests related to this device.
