## HS/ER-13 Task Force for Development of Population Monitoring Train the Trainer Workshops

Charges:

- 1. Develop training materials specific for public health staff that can be delivered using 'Train the Trainer' workshops and/or web-based training modules/videos. Use this material to update and augment the RRVC toolkit on the CRCPD website. Training materials should be ready for use by September 30, 2019.
- 2. Plan, execute and host a series of regional 'Train the Trainer' workshops (a minimum of two depending on the level of interest) and invite local health departments that are involved in planning for radiological emergencies to participate, with the understanding that the people attending would be willing and able to train others in population monitoring or other areas for which basic radiation protection training is found to be needed.
- 3. Pilot an initial Train the Trainer Workshop by September 30, 2019. Use lessons learned from Pilot Workshop to execute a second workshop in another area during the third quarter of 2020. Revise as needed the training materials in the RRVC toolkit based on lessons learned from the workshops. Training materials should be updated on the CRCPD website in the RRVC toolkit by September 30, 2020, and should include all presentations and training aids and other support materials needed for a trainer to conduct the population monitoring training.
- 4. Develop materials for web-based training of public health personnel in population monitoring which match the concepts and techniques developed for the workshops by December 31, 2020.
- 5. Provide guidance to CBRN on the enhancement of the Population Monitoring feature in Rad Responder.
- 6. Develop brief survey to send to CRCPD members to determine usefulness of feature.
- 7. Integrate Population Monitoring feature in TTT presentation material.
- 8. Hold workshop/exercise with various local and state representatives, including participants that have little to no experience with RAM, to deliver training and introduce the Rad Responder feature.
