Strategic Plan

As you know, each year the Board reviews the CRCPD Strategic Plan Goals and Objectives and prioritizes objectives for the year. Additionally, this year, we looked at the Strategic Plan as a whole to discuss if any revisions or updates we needed to the base document. The last time this plan was ratified by our membership was in 2015, so we decided it was time to bring it before membership again for a vote. During 2019 the Board participated in a facilitated discussion of our Strategic Plan. We continued this discussion into 2020 and in the end, we decided not to make any changes to the plan, but instead to request a re-ratification vote at the Business Meeting for this plan. It is our belief that the Goals and Objectives still match well with the mission of the CRCPD. Our areas of focus during this year have been:

- Maintain a Sound Fiscal Plan
- Increase the Availability of Electronic Based Information
- Promote Opportunities to Participate in Committee Activities
- Promote Standardization

Grants and Contracts

Ruth McBurney and her staff currently manage a large number of grants and contracts that are the base of the CRCPD budget. **They continue to identify ways to cut costs without impacting the services the CRCPD provides.** There have been challenges in recent years with finances and changes to grant requirements and methodologies. I commend our Executive Director and OED staff for their effort to keep the Board informed and address these challenges.

SSR Steering Committee

The reorganization of the Suggested State Regulations for Control of Radiation (SSR) Council and creation of a Steering Committee to help guide and prioritize the work of the SSR Committees has been an exciting project to watch unfold. Your incoming Chairperson, Angela Leek (IA), has dedicated much effort to ensuring the success of this project.

Occupational Safety and Health Administration

Along with that, the Board of Directors has communicated with Occupational Safety and Health Administration (OSHA) regarding our concerns about the varying radiation standards in use. Stay tuned for more on this topic from David Allard (PA) during the Business Meeting.

National Alliance for Radiation Readiness

The National Alliance for Radiation Readiness (NARR) is providing support to a two-year Centers for Disease Control and Prevention (CDC) project in partnership with the Association of State and Territory Health Officials (ASTHO). **The goal of this project is to develop a Public Health Clinical Framework for Cytokine Administration in Patients with Acute Radiation Syndrome following a Nuclear Detonation.** If this is an area of interest for you and you would like to be involved in the framework development, please let me know. I still currently serve as the CRCPD Liaison to the NARR, and Chris Williams (WA) is the alternate liaison.

Patrick Mulligan (NJ) -- Chair-Elect Designate



Patrick Mulligan is the Assistant Director of the Radiation Protection Program in the New Jersey Department of Environmental Protection. Pat brings over 29 years of experience in various disciplines of radiation protection and many years of management experience

to his position as Assistant Director. Pat's experience with the state is diverse and includes the evaluation of NRC regulation and the reactor oversight process, emergency response and preparedness, environmental monitoring, and transportation of radioactive materials. More recently Pat's duties include involvement with the Agreement State program's roles and responsibilities and the oversight of the Bureau of X-Ray Compliance that administers machine source registration and inspections as well as licensing for technologists.

Pat has gained national recognition in the field of radiological emergency preparedness for his work with the Conference of Radiation Control Program Directors. He was elected to serve on the CRCPD's Board of Directors as Member-at-Large from May 2013 through May 2016, assigned as the Chairperson of the Homeland Security/Emergency Response Council. Pat also received the CRCPD's James W. Miller Award for significant contributions to the field of nuclear emergency preparedness and response in May 2012.

Tanya Ridgle (LA County, CA) Member-at-Large Designate (3-year term)

Tanya Ridgle is a Principal Radiation Protection Specialist with Radiation Management at the Los Angeles County Department of Public Health. In this role, Ms. Ridgle responds to and investigates incidents involving radioactive materials, provides radiation safety training and support to local first responders and stakeholders, and assists with the development of radiological emergency plans and procedures.



Ms. Ridgle began her career in the Radiation Safety field immediately after receiving her Bachelor of Science in Chemistry from the University of California, Los Angeles in 2001. With over 20 years of experience, Ms. Ridgle has developed radiation safety manuals and guidance documents for nuclear pharmacies, served as Radiation Safety Officer on three California radioactive material licenses and performed audits of radioactive material licensees in various states throughout the United States. Ms. Ridgle has also been a Department of Homeland Security (DHS) certified Counter Terrorism Operations Support instructor since March 2015.

As a member of the Conference of Radiation Control Program Directors (CRCPD), Ms. Ridgle chairs the HS/ER-13 Task Force for Development of Population Monitoring Train-the-Trainer Workshops and also serves as a member on the SR-G Suggested Regulations - Part G Workgroup which reviews regulations for use of radionuclides in the Healing Arts.

Virtual Mammography Training Available

Virtual Mammography Training

The CRCPD is pleased to be offering a virtual Mammography Training session this year, May 12 -14, 2021. We usually hold the mammography training in person in conjunction with

the National Conference on Radiation Control. Even though everything is virtual this year, we are continuing to provide the training. Since travel is not involved, the training provides an opportunity for gaining up-to-date information and professional enrichment at a low cost. Registrations to date have already exceeded our average turnout at the in-person training sessions.

The H-11 Committee on Mammography has developed the training program, which includes presentations from radiologists, radiation therapists, and medical physicists, as well as updates on mammography facility inspection techniques. The training will provide 15 hours of continuing education through ASRT for mammography technologists and will fulfill 15 hours of continuing education requirements for mammography inspectors.

Remembering John P. Winston

On February 27, 2021, the radiological health and control community lost a friend, colleague and an irreplaceable member, John P. Winston. John passed away after a courageous, hard-fought battle with cancer.

John was with the Pennsylvania Department of Environmental Protection's Bureau of Radiation Protection (DEP) for about 35 years, working as a Radiological Health Physicist, inspecting and testing x-ray facilities, equipment, and linear accelerators. During those years, he mentored many junior staff regarding the proper methods and procedures to inspect dental, medical, and industrial facilities. John also assisted and counseled many dentists, technologists, doctors, and clinicians on how to perform equipment quality assurance to reduce patient radiation exposure, while optimizing image quality. He led the recent effort to update the DEP's medical x-ray regulations.

Although John's position description with the PA DEP never mentioned mentoring employees and going the extra mile with staff, John wrote his own job description with higher standards, greater responsibilities, and way more heart than we could ever ask of him. John continually encouraged and was a positive influence on his junior staff to step outside of their comfort zones and be positive role models. John's friends and colleagues at DEP were truly amazed at his level of professionalism and positivity, especially during undoubtedly the most difficult time in his life.

John was born in Erie on July 30, 1961, one of nine children of the late John Patrick Winston and Theresa Ann Barczynski Winston. John valued family and strove to keep relationship ties strong. John was a skilled craftsman and woodworker, and he used those gifts for both small and large projects which he gave generously to all the family. As a nature lover, John was often hiking with his wife, Chandra, near and far from home, or in the outdoors fishing. He also enjoyed brewing his own beer and reading books.

John is survived by his loving wife, Chandra L. Morgan Winston; son, Daniel Winston of Meadville; daughter, Taylor Wittmaak (fiancé Dylan Alasky) of Myrtle Beach, S.C.; six siblings; and many nieces and nephews. He was preceded in death by his parents, a brother, Patrick Winston, and a sister, Kelly Uhrmacher.

John Winston was an inspiration for so many. His influence spanned many decades and will not be soon forgotten. His work, dedication, honesty, and love for family will always remain in the hearts of those who knew him.
