#### **RIKKI WALLER**

## Director of the Idaho Radiation Control Program CRCPD Chairperson

G-73: Why is what you do important?

Rikki: Idaho is a non-licensure state which means anyone can take x-rays of people. I graduated college and became a registered radiologic technologist through American Registry of Radiologic Technologists (ARRT) in 1997. I wholeheartedly believe there must be education requirements to perform imaging exams. We have been able to require some training by adopting the CRCPD's suggested state regulations. By inspecting facilities using x-ray units, we are able to make sure the machines are working and used the way are supposed as well as ensuring the personnel has at least some basic radiation safety training.

#### G-73: What's the most interesting thing you've ever gotten to do at your job?

Rikki: I've driven to the middle of nowhere and the tops of mountains to perform x-ray inspections and I've performed one in a room that had a badger in a dog crate. The most interesting thing though was attending the 67th Annual Conference at International Atomic Energy Agency (IAEA) in September. There were over 60 countries in attendance and it was absolutely amazing!

G-73: What are some of the toughest challenges you've faced in your field?

Rikki: Idaho is a very rural state. Before our current bureau chief took over, we drove everywhere. We have x-ray facilities about 22

miles from the Canadian border. Fortunately, we now fly to get to the cities in northern Idaho. Along with most of the states, finding qualified personnel that are willing to come to work for state employee wages has been challenging.

G-73: Do you have any role models and if so, who are they and why?

Rikki: Most of the role models I have, I have met through my work with CRCPD. There are so many brilliant, knowledgeable people involved in the organization, I wouldn't know where to begin or end.

G-73: Do you have any tips for new or prospective radiation protection professionals looking to get involved in your line of work?

Rikki: Learn everything you can about the inspection process. I think one of the most important things to learn is how the end user of the x-ray machine is actually using it. This will help you understand why certain tests are performed and how the machine is actually used.

G-73: What is the most valuable lesson you've learned from your time in public service?

Rikki: Accountability, responsibility and integrity. As a steward of the taxpayers money, it's important to be all three.

#### IN MEMORIAM ROBERT "BOB M. HALLISEY

CRCPD and the world of radiation protection have lost a dear friend and mighty champion.

It is with heavy hearts that we inform you of the passing of Robert "Bob" M. Hallisey, Sr., on January 20, 2024, at his home in New London, New Hampshire. Bob succumbed to myeloid leukemia, the same disease that took

his beloved wife, Peg, 10 years earlier.

Bob was born in Cambridge, MA, on November 21, 1936. He attended Boston College and became a "double eagle" (two degrees), and then went on to earn his Master of Public Health degree at

UMass Amherst. He became a commissioned officer in the Public Health Service and rose to the rank of Captain before retiring after serving for 20 years.

Bob then became the Director of the Massachusetts Radiation Control Program (MA RCP), a position he held with distinction for 22 years until his retirement in 2003. While heading up the MA RCP, he also taught medical radiological safety at Tufts University.

During his years with the MA RCP, Bob was a vigorous supporter of CRCPD and served on the Board of Directors from 1985-1988, and as its Chairperson from 1999-2000. He encouraged members of his technical staff to attend National Conferences, participate in CRCPD working groups, and run for the Board of Directors; staff absences and travel status

for attending CRCPD activities were supported by Bob because he believed it promoted the uniform advancement of radiological safety standards and practices for his program and other state radiation control programs.

While working for the Commonwealth, Bob lived in Winchester, MA, where he was an

active and dedicated member of Winchester's Glee Club, "Staff & Key," and St. Mary's choir.

After retiring he moved to New Hampshire, where he volunteered countless hours at New London Hospital, the New London Historical Society, and by driving people to medical appointments on behalf of the Kearsage Area Council on Aging.

In addition to his wife Peg, he was predeceased by four of his siblings: Jacqueline Grondin, Larry, Barbara Murphy, and John, Jr. "Buddy". He is survived by three children, Robert, Jr., Barbara, and Chris, their spouses, two much loved grandchildren, John and Megan Hallisey, and by three remaining siblings: Margaret DiRoma, Maureen Frisoli, and William "Bill" Hallisey.

People who knew Bob don't need to be told how generous, kind, and sociable he was; he was a good man who truly loved people.

His children are planning a celebration of life event to be held in the spring.


