Collaboration with Partners

Through these meetings, I have the opportunity to share information about CRCPD and many of the amazing accomplishments achieved through our collective volunteer efforts. I want to share with you that many of our partner agencies and organizations value our work and are eager to find ways to collaborate with us. One example of ongoing collaboration is with the **Federal Radiological Preparedness Coordinating Committee** (**FRPCC**), where we are working with our Federal partners to identify gaps in radiological preparedness and response and looking for new ways to fill those gaps and sustain existing successful programs such as **Radiological Operations Support Specialist (ROSS) and CBRNResponder**.

This past week, CRCPD also contributed significant training content to the NREP conference through two 8-hour sessions. **One was the long-awaited delivery of the Population Monitoring Train the Trainer Workshop.** This content had been developed through support from the Centers for Disease Control and Prevention (CDC) before the pandemic, and the committee has been eagerly awaiting the opportunity to deliver the content. Congratulations to Tanya Ridgle and the entire committee for successfully delivering this important training material.

The other session was a collaboration between the ROSS program (HS/ER-4), CBRNResponder, and Radiation Emergency Services, LLC, to share new tools and developments and provide drill activities related to radiation emergency response to a radiological dispersal device. Thank you to all the volunteers who put in many hours of effort to provide this training experience.

NCRP's scope of research and publications cover a wide range of subject areas ranging from medical and dental practice, to emergency response, industrial, and natural sources of radiation exposure. For decades federal and state agencies involved with Radiation Control rely on the NCRP for timely information to update and implement our regulations.

I would encourage all those involved with state radiation control programs to take the time to peruse the NCRP's lists of Reports, Commentaries, and Statements, as these documents can be extremely valuable when tackling controversial radiation protection issues. For example, I'd recommend reading these recent publications as they are worth reviewing.

The meeting theme was *Opportunities in Radiation Science - From Low Dose to Climate Change.* NCRP President Kathy Held provided an excellent welcome, and ended the meeting with a recap of the work and publications by all the Council committees. She also led the annual business meeting at the end of the scientific sessions.

PRESENTATIONS

Annual Warren K. Sinclair Keynote Address, given by Joe Gray on *Developing a Long-Term Strategy for Low-Dose Radiation Research in the United States*.

Lauriston S. Taylor Lecture, given by Gayle Woloschak entitled *Long-Term Radiation Animal Studies - A Story Continues.*

Thomas S. Tenforde Topical Lecture, given by CRCPD's Past Chairperson Jill Lipoti entitled *Opportunities in Radiation Science - Applying Our Collective Knowledge to the Challenges of Our Time*, and as always, it was a thought provoking and eclectic talk. Several other presentations really stood out for me. These were on the topics of:

- radiopharmaceutical therapy;
- gonadal shielding during radiography;
- proton radiotherapy;
- evolving radiation protection standard during space exploration;
- DOE cleanup efforts with Alaskan Native American communities;
- effectiveness of uranium mill tailing radon barriers;
- small modular reactors;
- fuel cycle; and
- current nuclear power fleet and climate change.
