## Charges:

1. Monitor all areas related to existing and emerging radiation protection practice and regulation to identify when a Suggested State Regulations for Control of Radiation requires an update. This could be initiated by a need for parallel rulemaking processes with federal agencies or the revising or development of new regulations within existing SSR task forces, or it could be the need to create a new SSR task forces to properly address the new regulatory need.
2. Prioritize SSR revision priorities for each calendar year to ensure proper allocation of resources to complete the SSR drafting process within that year.
3. When an SSR is identified and prioritized for update or creation, activate the appropriate Suggested State Regulation Task Force in consultation with the SSR Council Chair. This will include:
  - Designating a chairperson, members, advisors and resource persons for the activated task force.
  - Drafting charges with a timeline to identify the scope of the changes that should be the focus of the task force.
  - Monitor the work of the task force to ensure timelines are met and ensure proper notifications and routing through the SSR process flow.
4. Upon publication of an SSR, inactivate the task force.
5. Coordinate with Council Chair regarding any emerging issues or questions related to existing SSR's or proposed language drafts.
6. Review proposed federal regulatory initiatives and provide analysis to the Council Chair related to potential impacts to existing regulations and the need for state or
