### **G-80 Task Force to Address NRC Rulemaking**

**February 2026**

#### **Specific Charges:**

1. Carefully review the NRC proposed rules related to Executive Order 14300 as they are made public, assess potential impacts, and identify existing CRCPD committees or task forces that will develop comments.
2. Assign development of comments on proposed rulemaking to specific Committees or Task Force Chairs. Set deadlines for comment submittal that provides sufficient time to review and combine with other working groups involved with the review.
3. Establish clear reporting mechanisms to monitor progress, evaluate effectiveness, and provide regular updates to the CRCPD Board on progress.
4. Consolidate comments received from Committees and Task Forces into a single document ensuring a unified organizational response for the CRCPD Board's approval.
