Chairperson Mulligan called the meeting order. A quorum was determined.

1. Introduction of Letter to NRC on EO 14300 Section 5(b) and 10 CFR Part 20, ALARA and LNT Proposed Changes (Mulligan)

Chairperson Mulligan provided an explanation of the letter as follows:

Around October/November, the Board of Directors started considering sending a letter to the NRC regarding the changes on ALARA and LNT. The Board of Directors sent a draft letter to the Director Members and met with the Director Members on December 15, 2025 to get their input. After input from the director members who attended and follow-up input, action was taken to revise the letter based on this information.

The revised letter is now a final draft that was sent to the Director Members. This meeting is to vote on sending this letter to the NRC.

The letter was originally addressed to Chairman David Wright and is now addressed to the new Chairman, Ho Nieh.

2. Discussion of Sending the Letter

Jeff Semancik comment: Feel it's too early to comment on the changes that haven't been issued and recommends not sending a letter until changes are seen.

David Howe comment: encourages the letter be submitted to register the director members concerns,

even if independent of the overall outcome.

Christopher Page comment: Clarifying this vote is to send the letter to NRC or approve a draft?

Pat Mulligan response: This is to approve the final draft be sent to NRC.

ACTION: Clark Eldredge (FL) moved to approve sending the draft letter to the NRC. The motion was seconded by Tera Patton (WV). A vote was taken, and the motion passed.
